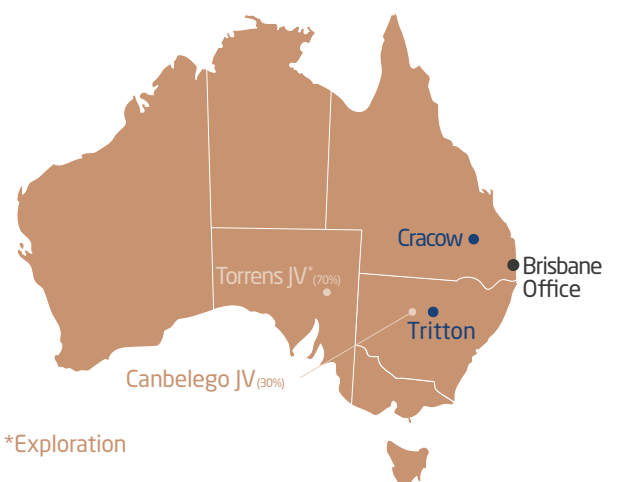

## Tritton Copper Operations

Tritton Copper Operations produces around 20,000 - 23,000 tonnes of copper annually.

Tritton includes multiple underground mines (Tritton and Murrawombie) and a 1.8 million tonne per annum processing plant. The operation also has an unrivalled pipeline of advanced mining projects and a highly-prospective tenement package covering some 2,160km<sup>2</sup> on which more than 750,000 tonnes of copper has been discovered to date.



## Cracow Gold Operations

Cracow Gold Operations produces around 74,000 ounces of gold each year.

Cracow currently produces 100% of its gold from underground mining. The operation has a consistent track record of replenishing identified Reserves and Resources and has multiple near mine and regional exploration targets.

Cracow has produced more than 1.4 million ounces of gold over its 15-year history.
